1. Corporate membership is only open to organisations.
2. Each Friends of the Gardens Corporate Card ("Card") entitles the company's employee and up to 3 accompanying guests complimentary admission to Flower Dome, Cloud Forest and OCBC Skyway, except during maintenance closure dates and special circumstance(s) as stipulated by Gardens by the Bay ("GB"), and each Corporate Card can only be utilised once per ticketed attraction per day. For events that are ticketed, admission fees will apply.
3. Each Cardholder can enjoy discounts at Gardens by the Bay Gift Shops and participating F&B outlets indicated on our corporate membership website, gardensbythebay.com.sg/corporatefriends (not applicable for Birthday Privileges).
4. Each Cardholder can enjoy discount off the usual price for the purchase of two-conservatories tickets (Flower Dome & Cloud Forest) for additional guests – 20% off Singapore Resident Rate and 10% off Standard Rate. Limited to a maximum of 4 tickets per transaction day and only for onsite purchase at GB Ticketing; not valid for single conservatory tickets.
5. Each Cardholder can enjoy discounted price on Floral Fantasy tickets (Cardholder + up to 3 accompanying guests' own use only) – Adult Ticket \$9 (U.P. \$20), Senior Ticket \$7 (U.P. \$20), Child Ticket \$7 (U.P. \$12). Each Cardholder can purchase a maximum of 4 discounted tickets per transaction, discounted tickets are only for the use of the Cardholder & up to 3 accompanying guests. Cardholder will need to present their membership card together with the discounted ticket(s) for admission to Floral Fantasy.
6. Corporate membership privileges does not include complimentary car parking, auto rider, outdoor gardens audio tours and shuttle service. Not applicable for ticketing promotions and giveaways, unless otherwise stated.
7. Corporate membership comprises either a 2-card package or 3-card package, and the corresponding number of cards will be issued accordingly.

11. Applications will not be processed if the application form or required information is incomplete.
12. Both the Corporate Membership Card and Employee Pass/Identification must be presented to enjoy complimentary admission to Flower Dome, Cloud Forest and OCBC Skyway.
